- 3. We registered with OSCR with just a mere framework of how our purpose and objectives were headed so it was necessary to focus on research (AoIn Project) to inform the process, and the outcome has been very momentous. The outcome has perfectly steered us towards the right direction, and based on that (and by consensus), we will request to make some minor alterations to our purpose as presented to OSCR.

#### **Updating Organisations' Details**

Our details on OSCR's portal does not have our website link so that needs to be rectified. Moreover, after deliberations based on the advice of our backend research, we have realised that our purpose directly aligns with the advancement of equality and diversity. And although our charitable activities depict advancement of spirituality and advancement of community development, our purpose is ultimately in alignment with promoting equality and diversity in the western milieu. After deliberations we agreed that our purpose as stated in our constitution and as presented to OSCR should be,

## **Appointment Of Chief Executive**

### **Budget For 2022-2023**

All appointments including the chief executive role shall be offered on voluntary basis, so the current financial obligations are,

- 5. Third-party contracts such as fundraising contracts.
- 6. Office supplies

In all we project that an average of £4,500.00 per month will be needed to meet all these obligations.
